Sub: Outcome of the 13th Committee of Creditors Meeting ("COC") of M/s Bloom Dekor Limited ("Corporate Debtor" or "BDL") which is currently undergoing Corporate Insolvency Resolution Process ("CIRP")

With reference to the captioned matter, this is to inform you that the 13th Meeting of CoC of M/s Bloom Dekor Limited-In CIRP was successfully convened on Saturday, 10th May 2025, pursuant to which e-voting ended on 21st May, 2025 wherein various matters were discussed as per the requirement of the Insolvency and Bankruptcy Code, 2016, key (material) decisions are as follows:

- 1. Company Appeal (AT) (Insolvency) No. 1401 & 1402 of 2024 i.e. Appeal as filed by successful resolution applicant before Hon'ble NCLAT on 22.07.2024 against the order dated 16.07.2024 passed by Hon'ble NCLT in IA (Plan) 24(AHM) 2024 i.e. (Interlocutory Application for the approval of Resolution Plan) in CP (IB) 127 of 2020, had been listed multiple times and the same is further listed on 23.05.2025.
- 2. An appeal i.e. Comp. App. (AT) (Ins) No. 1618 of 2024 which was filed by the EPFO department before the Hon'ble NCLAT against the order dated 03.07.2024 passed by the Hon'ble NCLT. Reply in relation to the same was filed before Hon'ble NCLAT. Multiple hearings were held in the said matter and the matter is further listed on 27.05.2025.

3. Resolutions which were approved by the 100% majority:

- Approved for necessary actions to be taken against one of the debtor of the corporate debtor due to non-receipt of payment.
- Approved to proceed with the filing of the necessary Purshis for withdrawal in the one of the ongoing arbritration proceedings.
