Sub: Outcome of the 17th Committee of Creditors Meeting ("COC") of M/s Bloom Dekor Limited ("Corporate Debtor" or "BDL") which is currently undergoing Corporate Insolvency Resolution Process ("CIRP")

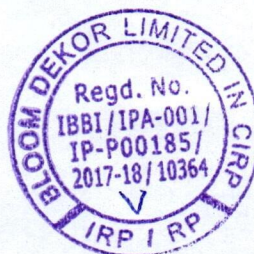
Dear Sir/Madam,

With reference to the captioned matter, this is to inform you that the 17th Meeting of CoC of M/s Bloom Dekor Limited-In CIRP was successfully convened on Friday, 21st November, 2025 pursuant to which e-voting ended on 23rd November, 2025 wherein various matters were discussed as per the requirement of the Insolvency and Bankruptcy Code, 2016, key (material) decisions are as follows:

1. Company Appeal (AT) (Insolvency) No. 1401 & 1402 of 2024 i.e., Appeal as filed by successful resolution applicant before Hon'ble NCLAT on 22.07.2024 against the order dated 16.07.2024 passed by Hon'ble NCLT in IA (Plan) 24(AHM) 2024 i.e. (Interlocutory Application for the approval of Resolution Plan) in CP (IB) 127 of 2020, had been listed multiple times. The matter is further listed on 25.11.2025.

2. Resolutions which were approved by the 100% majority:

- Approved and ratified the proposal to raise Interim Finance from CoC member, Sampati Securities Limited, to meet the immediate funding requirements of the Corporate Debtor as per the terms and conditions as mentioned in the Sanction Letter attached, the said amount shall be considered as part of CIRP costs, and the Resolution Professional was be and hereby authorized to execute necessary documents and take all actions as may be necessary to give effect to this resolution, in the fiduciary capacity not incurring any personal liability and no reporting shall be made to CIBIL in this regard, and it will not have any adverse impact on the personal CIBIL score or credit profile of the Resolution Professional.



- Approved and ratified the convening of the 17th CoC Meeting of Bloom Dekor Limited on a shorter notice in order to discuss some urgent matters requiring attention/approval.

We request you to kindly take record of above matters.

Note: CS Tushar Dineshbhai Donda has resigned from the position of Senior Company Secretary and Compliance Officer of the corporate debtor M/s. Bloom Dekor Limited-In CIRP w.e.f. 19th November, 2024. Therefore, the said outcome is being signed by the Resolution Professional.

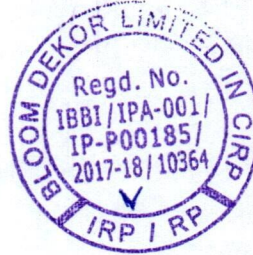
