**Sub: Outcome of the 21<sup>st</sup> Committee of Creditors Meeting ("COC") of M/s Bloom Dekor Limited ("Corporate Debtor" or "BDL") which is currently undergoing Corporate Insolvency Resolution Process ("CIRP")**

**Ref: Disclosure under Regulation 30(2) read with sub-clause 16(g) of Para-A of Part-A of Schedule III of Securities and Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015.**

With reference to the captioned matter, this is to inform you that the 21<sup>st</sup> Meeting of CoC of M/s Bloom Dekor Limited-In CIRP was successfully convened on Wednesday, 11<sup>th</sup> March 2026 wherein various matters were discussed as per the requirement of the Insolvency and Bankruptcy Code, 2016, key (material) decisions are as follows:

**Resolutions which were approved by 100% majority:**

- Approved the Resolution Professional to file an Interlocutory Application before the Adjudicating Authority for exclusion of the litigation period pending before the Hon'ble NCLAT till the disposal of the order dated 13.01.2026 and to grant extension of the CIRP period by 120 days, along with condonation of delay. Further, approved the appointment of Thakkar and Pahwa, Advocates for filing the aforesaid Interlocutory Application at a professional fee of Rs. 25,000/- plus OPE on actual basis, with the said expenses forming part of the CIRP Costs.
- Approved and ratified the extension granted to the Resolution Applicants (RAs) for submission of the revised Resolution Plan till 16.03.2026, subject to the approval of the Interlocutory Application for exclusion and extension of the CIRP period to be filed before the Hon'ble NCLT.
- Approved and ratified the payment of Head Office property tax along with applicable interest and penalty, and confirming that the said expenses shall form part of the Corporate Insolvency Resolution Process (CIRP) Costs.
- Approved and ratified the payment of Rs. 17,491 into the gratuity account for obtaining the renewal premium quotation and ensuring employee gratuity coverage of the Corporate
