

SC notice to Gujarat govt on Asaram’s bail petition challenging HC order

THE SUPREME Court has sought a response from the Gujarat government on an appeal filed by jailed self-styled godman Asaram rejecting his bail plea in a rape case filed against him by a woman in 2013.

A bench of Justices Ajay Rastogi and CT Ravikumar issued notice to the state government on Asaram’s plea challenging the December 10, 2021 order of the Gujarat high court. “Applications for exemption from filing a certified copy of the impugned judgment and exemption from filing official translation are allowed. Issue no-

tice returnable on September 7, 2022,” the bench said. In his bail plea, Asaram sought relief on the ground that he is already above 80 years of age and that his health was deteriorating. In 2018, Asaram was sentenced to life imprisonment by a special court in Rajasthan for raping a minor at his ashram.

In Gujarat, two Surat-based sisters had lodged separate complaints against Asaram and his son Narayan Sai, accusing them of rape and illegal confinement.

The elder sister, in her complaint against Asaram, had accused him of repeated sexual assaults between 2001 and 2006 when she was staying at his ashram in the Motera area of Ahmedabad.

Student sticks Rs 500 note on answer sheet to bribe examiner, gets debarred

A CLASS 12 student has been debarred from appearing for the Gujarat Secondary and Higher Secondary Education Board (GSHSEB) examinations for a year after he apparently tried to bribe the examiner by sticking a Rs 500 note inside his answer sheet, an official said on Friday. The boy is one of the 22 students of the Class 12 Science stream who faced disciplinary action, the official said.

The results of the Class 12 board exams were declared in May. “In a bid to clear the examination, a student of the science stream, who appeared by the

board exam in April, stuck a Rs 500 note inside the answer sheet of the Chemistry paper with glue. Someone must have told him that such tricks might work to pass the exam,” the board official said.

When the examiner found the note while correcting the paper, he reported it to the board. After recording the student’s statement, the exam committee withheld his results and banned him from appearing for the exam for the next one year, the official said.

“As a punishment, he has to now appear for the board exam in March next year. Although students who fail two papers are allowed to appear in a supplementary exam in July, this student was not allowed to sit for that exam as a punishment,” he said.

Police, forensic experts visit hotel to probe fire incident in Jamnagar

POLICE PERSONNEL, forensic experts and officials of the electricity department visited the five-storey hotel in Gujarat’s Jamnagar city on Friday morning for a detailed investigation into the major fire that had broken out at the place the previous day, an official said.

As many as 27 people were rescued after the blaze erupted at the hotel, located nearly 20 kms from here, on Thursday evening. Investigation has revealed that short circuit had caused the fire.

“A primary probe revealed that the fire spread in a very short time due to the use of alu-

minum composite panel or ACP sheets on the facade of the hotel building,” Chief Fire Officer of Jamnagar Municipal Corporation, K K Bishnoi, said.

“These are flat panels made up of two aluminium sheets and a polyethylene sheet stuffed in between. A short circuit in the electric panel on the ground floor outside the hotel ignited fire and it spread quickly because of the material used in these sheets,” he added.

A team of Meghpar police station along with officials from the Forensic Science Laboratory and from the electricity department visited the hotel on Friday morning for a detailed investigation and collection of samples for analysis, said sub inspector Y B Rana.

“The fire started at about 7.30 pm on Thursday and spread quickly. At the time of fire, 27 guests were staying in 18 out of the total 36 rooms,” said Rana.

Along with the hotel staff, all the 27 guests were rescued by the police and fire brigade staff. Rana said, adding the incident neither claimed any life, nor left anyone seriously injured. The flames were brought under control around 10.30 pm.

As many as 18 fire tenders of the Jamnagar civic body along with the firefighting vehicles from Reliance (which has a refinery in the area), Gujarat State Fertilizers and Chemicals Limited (GSFC) and a power plant were rushed to the spot to douse the fire.
